DECLARES to approve the following:

The “BikePackers - la Piave River” is not a race, but a group cycling ride where **the participant will be responsible for him/herself and for any damage caused to third parties**. S/he is aware that it’s a criminal offence to make false statements in accordance with the art. 46 and 76 of the Presidential Decree 445/2000 under his/her own responsibility.

Art. 1 - Enrolement

All persons of all nationality who have reached the age of 18 at the time of the enrolement are admitted to the group. **Under 18’s can participate if accompanied by an adult (who will sign this release form).**

Art 2 - Regulation

“BikePackers - La Piave River” is a group ride on paved roads, gravel roads and paths; the track will always be open to traffic therefore it is MANDATORY for all participants to comply with road traffic regulations.

The participant acknowledges and is fully aware that **the route is not marked but it’s identifiable through the use of a gps track**; the participant travels at his/her own risk and agrees to consider him/herself on a personal ride, entitled to the same rights as any other user of paths and roads.

S/he is aware that there are no assistance services; there is no recovery service and there are no obligations on the part of the organizers to search for missing participants. The participant is aware that it’s his/her free choice to join this cycling ride and undestands it’s a recreational event.

Therefore the organizers are fully released from any responsibility related to the cycling event. They are also released from any liability regarding possible events happening to the cyclists like: crashes, road loss, physical problems, accidents, fire, thefts, etc.

This cycling event is to be considered a spontaneous gathering of independent cyclists meeting up for a free and private ride.

The participant renounces to take any legal action against the organizers. S/he understands that the organization is non-professional and that it acts for recreational purposes **without the requirements ??** (ex art. 1174 Cod.civ.).

The participant accepts and agrees to respect and keep clean the areas along the route: meadows, woods, paths, farmland and fields and s/he agrees to keep the waste produced during the cycling and to throw it away in the dedicated bins.

Art. 3 - Mandatory kit

For your personal safety it's mandatory to use an approved **protective helmet** and to equip the bicycle with **bell** and **lights** well fixed on the frame (front light-white, rear light-red).

Art. 4 - Final points

With the enrolment, each participant:

- declares to have read this release form and to agree and accept it in all its parts;
- declares that s/he understands that this is a group cycling event, recreational and not competitive;
- declares to use caution when dealing with challenging sections without causing danger or damage to him/herself or to other cyclists;
- declares to have experience and to be aware that the route is not marked, it is not monitored and there are no emergency areas and / or rescue personnel along the track;
- declares to be aware and to have experience in cycling on routes and paths;
- declares to have experience and to be aware of the possibility of encountering adverse weather conditions;
- declares that his/her equipment is in excellent condition and ready to use;
- is responsible for his/her behavior during and after the event;
- declares that s/he is physically fit, in excellent condition without any health-related problem or contraindications so s/he can participate to this group cycling ride in total safety.
- expresses his/her consent to the use of his/her personal data accordingly with the provisions of the Privacy Act n. 196 of 30/06/2003;
- gives the organizers the broadest consent to use any of his/her image, video, photo, etc. recorded during the days of the event either for profit or for all the ways permitted by law. Once enrolled, the participant gives the organization the right to transfer such material to third parties; s/he authorizes the organizers, free of charge, to use his/her images, being them still and / or moving taken during the event throughout its duration.

The present authorization for the use of one's own image must be intended for an unlimited period of time and space, all over the world, without any territorial limits. It's also intended for the use in various publications and videos, including, but not limited to, promotional and / or advertising materials on all media.

The organizers can also give the rights of use provided for in this agreement to third parties and to their institutional and commercial partners.
